## **PLEDGE INFORMATION**

### **FAIR SHARE DUES**

We have Fair Share dues which is based on our Annual Budget divided by the total number of members of Temple. Some payment must accompany application.

Some members pay more than Fair Share and some members pay what they can if paying below Fair Share. All pledges are reviewed by the Finance Committee and are kept confidential. After the Finance Committee has agreed to the pledge, the Board of Directors votes to approve all applications.

Dues can be paid all at once, monthly, quarterly or by other arrangements. At least fifty percent of the annual pledge and other obligations shall be paid within five months of the start of the fiscal year and the remainder shall be paid within ten months of the start of the fiscal year to be considered in good standing. Our fiscal year runs July 1<sup>st</sup> – June 30<sup>th</sup>.

Other notes:

- Pro-rated dues for membership for a part of a year.
- Fees paid for High Holy services are credited to dues for the same fiscal year.
- Tuition for Religious School and Hebrew School students (held at the UJCVP) are both free for our members.

### **DUES TO SUPPORT THE RABBI FUND**

The Rabbi's compensation is paid from a Rabbi Fund within our Dues structure. This fund was established to ensure that we might continue to have a professional Rabbi lead our congregation.
